## RECITALS

- A. The Employer desires the execution of certain works known as the delivery, installation and commissioning of wind energy converters (hereinafter "WECs") for a 15 MW wind farm, at a site in Saint Secondin, FR-86350, Vienne, France. These works shall also include the building of access roads and crane platforms, the foundations and electrical works.
- B. The Contractor has offered to execute the aforementioned works, namely to design, deliver, install and commission 5 WECs, type ENERCON E-115 with 122.05 m hub height and 3 MW rated power for the site mentioned above.
- C. The Employer accepts the Contractor's offer, and he agrees that in consideration for the execution of the works by the Contractor, the Employer shall pay the Contractor in accordance with the Contract. The Contract becomes effective once each Party has signed and delivered it to the other Party.

NOW, THEREFORE, in consideration of the recitals stated above which all Parties agree are accurate and complete, the agreements, promises and warranties set forth below and other good and valuable consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

## **BASIS OF CONTRACT**
